HOT 97.1 "TEXT TO WIN DISNEY ON ICE TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **HOT 97.1's "Text to Win Disney On Ice Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility. - 2. Contest Period. The Contest entry period will begin at 6:00am ET on Tuesday, January 2, 2024 and will run weekdays from 6:00am ET until 10:00am ET through 10:00am ET on Friday, January 5, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.** There is one (1) way to enter:
 - <u>Text</u>: Send a text message with the keyword DISNEY spelled correctly to 1-844-971-4971 during the Contest Period. All entries must be received by 10:00am ET on Friday, January 5, 2024 to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider. Limit one (1) entry per person per phone number.
- 4. **Winner Selection.** On or about 11:00am ET on Monday, January 8, 2024, Station will select FOUR (4) potential winners in a random drawing from among all valid entries received by Station during the Contest Period to win a prize. Each winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification as a winner will result in disqualification and forfeiture of the prize.

IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. Station and any Sponsors make no representation or warranty about the safety of any prize. - 7. Entry Conditions and Release.
