HOT 97.1'S "WIN KNOEBEL'S TICKETS" CONTEST OFFICIAL RULES

The Station will conduct the **HOT 97.1's "Win Knoebel's Tickets"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. The Contest is subject to all applicable federal, state and local laws and regulations. The Contest entry period will begin at 2:00pm ET on Monday, June 16, 2025 and will run Monday, June 16, 2025; Tuesday, June 17, 2025, Wednesday, June 18, 2025 and Friday, June 20, 2025 from 2:00pm ET through 7:00pm ET through 7:00pm ET on Friday, June 20, 2025 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. Between 2:00pm ET and 7:00pm ET each contest day (each, a "Selection Day"), when the Station plays sounder (each, the "Sounder"), listeners must call the Station at 1-844-971-4971. Caller NINE (9) to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. LIMIT ONE PRIZE PER PERSON.

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. 6. Entry Conditions and Release.
